The undersigned natural person of the age of eighteen (18) years or more, acting as an incorporator of a corporation under the Texas Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation:

**ARTICLE ONE**

The name of the corporation is CROWN CORRECTIONAL TELEPHONE, INC.

**ARTICLE TWO**

The period of duration of the corporation is perpetual.

**ARTICLE THREE**

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Texas Business Corporation Act.

**ARTICLE FOUR**

The aggregate number of shares which the corporation shall have the authority to issue is one million (1,000,000) shares of common stock, each share having no par value.

**ARTICLE FIVE**

The corporation will not commence business until it has received for the issuance of its shares consideration of the value of at least One Thousand and No/100 dollars (\$1,000), consisting of money, labor done or property actually received.

**ARTICLE SIX**

Preemptive rights are expressly denied.

**ARTICLE SEVEN**

Cumulative voting is prohibited.

**ARTICLE EIGHT**

The corporation shall indemnify its officers and directors and may indemnify its other employees or agents to the full extent permitted by law if any such person was or is a party, or is

threatened to be made party, to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he is or was a director, officer, employee or agent of the corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him in connection with such action, suit or proceeding. Such right or indemnification shall not be deemed exclusive of any other rights to which such person may be entitled under any bylaw, agreement or vote of shareholders or otherwise.

#### **ARTICLE NINE**

No director of the corporation shall be liable to the corporation or any of its shareholders or members for monetary damages for an act or omission in the director's capacity as a director, provided, however, that the limitation of liability contained in this Article shall not eliminate or limit the liability of a director for:

1. A breach of a director's duty of loyalty to the corporation or its shareholders or members;
2. An act or omission not in good faith or that involves intentional misconduct or a knowing violation of the law;
3. A transaction from which a director received an improper benefit, whether or not the benefit results from an action taken within the scope of the director's office;
4. An act or omission for which the liability of a director is expressly provided for by statute or;
5. An act related to an unlawful stock repurchase or payment of a dividend.

#### **ARTICLE TEN**

The initial bylaws of this corporation shall be adopted by the board of directors. The power to alter, amend or repeal the bylaws or adopt new bylaws is reserved to the Board of Directors.

#### **ARTICLE ELEVEN**

The street address of the initial registered office of the corporation is 912 Ambling Way Court, Granbury, Texas 76049 and the name of the initial registered agent at such address is William Ryan Bartula.

#### **ARTICLE TWELVE**

The number of directors constituting the initial board of directors is three, and the names and addresses of the persons who are to serve as the initial directors until the first meeting of the shareholders or until their successors are elected and qualified are:
