PROCEDURAL ORDER (Grants Motion) 9 BY THE COMMISSION: 10 On January 26, 2017, Gila River Telecommunications, Inc. ("Gila River") filed a Formal 11 Complaint ("Complaint") with the Arizona Corporation Commission ("Commission") against 12 TracFone Wireless, Inc. d/b/a Safelink Wireless ("TracFone"). 13 On January 31, 2017, TracFone filed a Consent to Email Service. 14 On February 3, 2017, a Procedural Order regarding Consent to Email Service was filed. 15 On February 10, 2017, Gila River filed a Consent to Email Service. 16 On February 21, 2017, TracFone filed an Unopposed Motion for Extension of Time to File 17 Answer, requesting an additional 20 days to file its Answer due to a potential conflict of interest with 18 their counsel of record. 19 On March 6, 2017, by Procedural Order, TracFone's Motion for an extension of time to file its 20 Answer was granted. 21 On March 13, 2017, TracFone filed an Answer and Motion to Dismiss to the Complaint. On 22 the same date, TracFone filed a Consent to Email Service. 23 On March 14, 2017, by Procedural Order, TracFone's request for email service was approved. 24 On March 20, 2017, TracFone filed a Notice of Appearance and Request to be Added to Service 25 List. 26 27

On March 24, 2017, Gila River filed an Unopposed Motion to Extend Response Date, requesting to extend the time deadline, from March 27, 2017 to April 20, 2017, to file a response to TracFone's Motion to Dismiss.

On March 29, 2017, by Procedural Order, TracFone's Consent to Email Service was approved.

Also on March 29, 2017, by Procedural Order, Gila River's Consent to Email Service was approved.

IT IS THEREFORE ORDERED that Gila River Telecommunications, Inc. is hereby granted an extension of time until **April 20, 2017**, to file its response to TracFone's Motion to Dismiss.

IT IS FURTHER ORDERED that each party or prospective party shall refer to the Procedural Order Regarding Consent to Email Service issued in this matter on February 3, 2017, for additional information regarding the process to consent to service by email. Information regarding Consent to Email Service is also available on the Commission's website (www.azcc.gov) by clicking on "Email Service Consent."

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31, 38, 39, and 42 and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.

IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
