7	IN THE MATTER OF THE APPLICATION OF COLDWATER CANYON WATER COMPANY FOR APPROVAL OF AN EMERGENCY RATE
8	INCREASE. PROCEDURAL ORDER
9	BY THE COMMISSION:
10	On March 15, 2017, the Utilities Division ("Staff") of the Arizona Corporation Commission
11	("Commission") filed a request to open this docket to process the forthcoming emergency rate
12	application of Coldwater Canyon Water Company ("Coldwater Canyon" or "Company").
13	On March 27, 2017, the Company filed its emergency rate application requesting the
14	implementation of an emergency surcharge to cover the costs of repairing leaks in its only water storage
15	tank. According to the Company, the surcharge is necessary to ensure the continued safe and adequate
16	water service to its 216 customers.
17	On March 29, 2017, a Procedural Order was issued scheduling a procedural conference to
18	commence on April 6, 2017, to discuss the scheduling of a hearing and other procedural matters.
19	On April 6, 2017, the procedural conference was convened, as scheduled, with Staff appearing
20	through counsel, and the Company appearing through its president, Mr. Roger Wagner. At that time,
21	Mr. Wagner informed the Commission that repairing the storage tank may no longer be a viable option
22	given the age and condition of the tank. As a result, Mr. Wagner requested additional time to explore
23	other options and file an amended emergency rate application. The parties agreed to convene a
24	procedural conference on May 5, 2017, to provide the Commission with an update in this matter.
25	IT IS THEREFORE ORDERED that a procedural conference for the purpose of discussing
26	the further processing of this matter shall commence on May 5, 2017, at 10:00 a.m., or as soon
27	thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Hearing Room

1 No. 2, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that each party or prospective party shall refer to the Procedural
Order Regarding Consent to Email Service issued in this matter on March 29, 2016, for additional

7 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules

9 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 – Unauthorized
 10 Communications) applies to this proceeding and shall remain in effect until the Commission's Decision
 11 in this matter is final and non-appealable.

IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
 hearing.
