Enclosed for filing with the Commission is an original plus thirteen (13) copies of revisions to CenturyLink's Competitive Exchange and Network Services Tariff No. 3. The following revisions are included in this filing:

Effective June 1, 2017, the Facility Relocation Cost Recovery Fee will be increased to \$1.00. This surcharge is assessed for the recovery of the costs associated with the relocation of network facilities or infrastructure changes mandated by City, County, State, or Federal authorities, or any other governmental entity of any kind. Customers are being notified by bill message of this change during the month of May.

This filing proposes to add a clarifying footnote to the rate pages for flat and measured rate service explaining that the sum of the access line rate plus the Facility Relocation Cost Recovery Fee may not exceed the maximum rate. That explanation already exists in greater detail in Section 2 in the regulations pertaining to the Facility Relocation Cost Recovery Fee, and is being added to these pages as a reminder that flat rate residence lines will now be at their maximum allowable rate. This filing also deletes an outdated footnote associated with maximum rates for Public Access Line Service.

**2.6 SPECIAL TAXES, FEES, CHARGES (CONT'D)**

**B. Facility Relocation Cost Recovery Fee**

This surcharge is for the recovery of the costs for the relocation of the network facilities or infrastructure mandated by the City, County, State or Federal authorities, or any other governmental entity of any kind. This incremental charge is billed monthly per retail access line and will be identified on the bill as a Facility Relocation Cost Recovery Fee.

[1] The current surcharge amount will be recalculated annually and any necessary adjustments in the resulting rate will be filed in accordance with R14-2-1109. The total amount to be collected will consist of the amount of unreimbursed facility relocation costs mandated by any and all Arizona government entities during the full calendar year immediately following the vintage year of costs associated with the currently effective surcharge rate. The rate will be calculated by dividing these costs by twelve to derive an average monthly recovery amount, and then dividing the monthly recovery amount by the number of chargeable in service voice access lines. The number of chargeable access lines will consist of the number of lines in service at the end of the immediately preceding calendar year, adjusted for the expected line loss rate. The resulting current surcharge amount plus the current monthly rate for the associated monthly access line rate shall not exceed the maximum allowable rate for the service as specified in the respective tariff section for each service. The Company shall provide the Commission Staff with any information requested in support of its calculation of the Facility Relocation Surcharge rate.

**5.2.2 LOW USE OPTION SERVICE**

A. Description

1. Residential service for which message unit charges are based on the number of local calls placed. The Low Use Option includes an individual exchange access line with touch-tone capabilities. The following optional features are allowed at the rates found elsewhere in this Tariff:

- Caller ID Line Blocking,
- Wire Maintenance
- Toll Restriction

Features other than the above will not be allowed.

2. Calls to directory assistance, 911 and telephone repair service are not subject to message unit charges.

**5.2.4 FLAT RATE SERVICE**

This service entitles customers to an unlimited number of calls within the local calling area. Incremental charges, as shown in 5.1.6.A., apply to service outside the exchange base rate area. Zone charges do not apply to business services.

**A. Rates and Charges**

1. The nonrecurring charge associated with the provision of flat rate service applies:
  - To install each access line;
  - For connecting an access line when changing a grade of service from PBX service.

**C. Responsibility of the Customer**

1. The PAL customer will be responsible for:

- a. The installation, operation, and maintenance of any PSP pay telephone used in connection with this service.
- b. The rates and charges incurred on the Public Access Line. Toll adjustments will not be allowed on the PAL account, unless due to Company error.
- c. The refund of coins when lost or collected in error.
- d. The payment of Maintenance of Service Charges for visits made by a Company employee to the customer's premises when a service difficulty or trouble report results from the PSP pay telephone.

**D. Rates and Charges**

- 1. Each call to Directory Assistance is charged for and will not be subject to an allowance.
- 2. Exchange zone increments will be applied to PAL Service furnished within exchange zones.
- 3. Basic Public Access Lines will be provided at the following rates and charges.
