Pursuant to A.A.C. R-14-2-2405, UNS Electric, Inc. ("UNS Electric" or the "Company") is required to submit an Energy Efficiency Implementation Plan ("EE Plan") for Arizona Corporation Commission review and approval on June 1<sup>st</sup> of each odd year, or annually at the election of the Company. UNS Electric has been conducting a comprehensive and strategic review of energy efficiency ("EE") programs and measures to analyze: (i) the cost-effective potential of EE as a resource in UNS Electric's long-term integrated resource plan; (ii) new programs and technologies designed to manage or reduce peak demand; and (iii) the associated rate impact on customers. As a result of this extensive review, the Company needs additional time to submit its 2018 EE Plan. Accordingly, UNS Electric hereby requests an extension of time until August 1, 2017 to file its 2018 EE Plan.
