There is no question but that this up-grade and reliability in providing water to Truxton customers is needed. Two observations are brought to your attention:

1) The math as stated in the 'Public Notice' is not consistent with stated 'per year to meet the debt service coverage requirement.' A) VVPOA

meters will generate \$12, 940.80 annually for five meters; B) Homeowners will generate approx. \$39, 636.00 annually (est'd. 900 customers) which includes the 'loan surcharge' and 'debt service surcharge' combined from number published. This totals \$52, 577.00per year...does not meet the

stated \$92, 437.00 required. This amount seems very high/or a long-term and low interest loan!!!

2) The Neal family sold several thousand acres surrounding the well site which is to be upgraded with electric power and motors. The new owner has been drilling water wells in the surrounding area and within close proximity of Truxton's well site. Question: If electric service isprovided to Truxton will the Nut farmer utilize the new electric service line that VVPOA will pav the costs to bring in??? /(this is the case then the costs should be shared. I am requesting the staff to investigate the matter, which is important, due to the/act Truxton'swell is not used continuously, but seasonally, whereas the nut farmer could be using power year-round.

Thank you for your attention and investigation into these matters. Clarification will be appreciated.
