TRUXTON CANYON WATER COMPANY, INC. CUSTOMER NOTICE

Docket No. W-02168A-17-0042

On April 11, 2017, per Decision No. 76072, the Arizona Corporation Commission ("Commission") authorized the Truxton Canyon Water Company, Inc. ("Company") to implement a monthly Water Infrastructure Finance Authority ("WIFA") Loan Surcharge as described below. The WIFA Loan Surcharge will become effective after the Company closes the WIFA loan and the Commission authorized the implementation of this surcharge.

On April 11, 2017, per Decision No. 76072, the Commission also authorized the Company to implement Debt Service Coverage ("DSC") Surcharge as described below. The DSC Surcharge will become effective on the first of the month following the month in which the Company files its application to implement the WIFA Loan Surcharge, unless Staff files an objection or requests additional time to analyze the surcharges.

Please note that the surcharges apply different rates to meters serving the Valley Vista Property Owners Association ("VVPOA") golf course and common areas and meters serving all other customers.
