
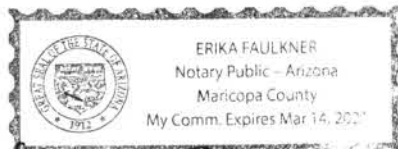

NOTICE OF INTENT TO DISCONTINUE RESIDENTIAL LONG DISTANCE SERVICES

ANPI Business, LLC ("Applicant") has filed with the Arizona Corporation Commission ("Commission") an application to discontinue residential long distance services, including intrastate, interstate, and international long distance service, in the State of Arizona. Applicant seeks to have its customer(s) choose another long distance carrier and transition service by June 1, 2017.

A.A.C. R14-2-1107 provides that the Commission may act on an application to discontinue services without a hearing, or with a hearing, if one is requested by any party. Applicant or any other party must request a hearing within thirty (30) days of the date of this notice, or the Commission will rule on the application without a hearing.

The application, report of the Commission's Utilities Division Staff, and any written exceptions to the Staff report prepared by the applicant are available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007, and at Applicant's office at 2300 Berkshire Lane North, Suite 4, Minneapolis, MN 55441.

Under appropriate circumstances, interested parties may intervene in the proceedings, and participate as a party. Intervention shall be in accordance with the A.A.C. R14-3-105, except that all motions to intervene must be filed on or within thirty (30) days of the date of this notice.
