**MOTION FOR ADMINISTRATIVE
CLOSURE**

Global Water-Santa Cruz Water Company, LLC (“Santa Cruz”) and Global Water-Palo Verde Utilities Company, LLC (“Palo Verde”)(with Santa Cruz, the “Applicants”) move that this docket be administratively closed.

Applicants filed a Verified Application for a waiver of the Commission’s Affiliated Interest and Holding Company Rules, A.A.C. R14-2-801 et seq., (“Affiliate Rules”) to allow a merger transaction whereby Global Water, LLC, the immediate parent of Santa Cruz and Palo Verde, would also become the parent of Eagletail Water Company, L.C. (“Eagletail”). Under Rule R14-2-806(C), if “the Commission fails to approve, disapprove, or suspend for further consideration an application for waiver within 30 days following filing of a verified application for waiver, the waiver shall be effective on the 31st day following filing of the application.” Over 31 days have expired since the Verified Application was filed on March 22, 2017. Accordingly, the waiver requested in the Verified Application has taken effect by operation of law.


Further, Applicants provide notice that the merger transaction described in the Verified Application has closed, and that Eagletail is now a wholly-owned subsidiary of Global Water,

1 LLC. Global Water, LLC and Eagletail look forward to providing Eagletail's customers with
2 improved financial, technical, and managerial capabilities of Global Water.

3 The waiver requested in the Verified Application has taken effect, and the merger
4 transaction has closed. Accordingly, there is no need for this docket to remain open, and the
5 Applicants request that the docket be administratively closed.


