On April 24, 2017, Communications Network Billing, Inc. ("CNBI") filed an informational letter notifying the Arizona Corporation Commission ("Commission") of the change in stock ownership. Specifically, 100 percent of the common stock of CNBI will be purchased by Mr. Martin J. Tibbitts, Individual, 19992 Kelly Road, Harper Woods, Michigan 48225 ("Buyer") from Ms. Cristina Tucker, Individual, 200 South Virginia Street, 8th Floor, Reno, Nevada 89501 ("Seller").

The transaction will have no effect on the operations of CNBI, which remains the holder of its Certificate of Convenience and Necessity ("CC&N") to provide long distance services in Arizona. The change in stock ownership will be seamless to consumers in Arizona because there will be no changes in CNBI's business practices, customer service offerings, and/or customer billing.

Since this filing is a notification, no Commission action is required. Staff requests that this docket be administratively closed. This Administrative Closure should not be construed as either an approval or denial by the Commission.


