STOCK OWNERSHIP. (DOCKET NO. T-20793A-17-0118)

On April 24, 2017, Conectado, Inc. ("Conectado") filed an informational letter notifying the Arizona Corporation Commission ("Commission") of the change in stock ownership. Specifically, 100 percent of the common stock of Conectado will be purchased by Mr. Martin J. Since this filing is a notification, no Commission action is required. Staff requests that this docket be administratively closed. This Administrative Closure should not be construed as either an approval or denial by the Commission.
