RE: **REQUEST FOR ADMINISTRATIVE CLOSURE - IN THE MATTER OF THE APPLICATION OF LEGACY LONG DISTANCE INTERNATIONAL, INC. DBA LEGACY INMATE COMMUNICATIONS NOTICE OF OWNERSHIP CHANGE OF LEGACY INMATE COMMUNICATIONS TO JAIL EDUCATION SOLUTIONS, INC. DBA EDOVO (DOCKET NO. T-03669A-17-0097).**

On April 5, 2017, Legacy Long Distance International, Inc. dba Legacy Inmate Communications ("Legacy") and Jail Education Solutions, Inc. dba Edovo ("Edovo") jointly, "the Parties", filed an informational letter notifying the Arizona Corporation Commission ("Commission") of the direct transfer of ownership of Legacy to Edovo with Legacy ultimately operating as a direct wholly-owned subsidiary of Edovo.

On January 27, 2017, the Parties entered into a Stock Purchase Agreement ("Agreement") in which, Edovo will acquire 100 percent of the voting equity interests of Legacy ("Proposed Transaction"). At the closing of the Proposed Transaction, Legacy will become a wholly-owned subsidiary of Edovo. This change in control does not involve a transfer of operating authority, assets or customers in Arizona or elsewhere. Legacy's corporate identity, name and operations, and the rates, terms and conditions of its service offerings will remain intact after the Proposed Transaction.

Given the nature of this transaction as represented by the Parties and discussed above, Commission approval is not necessary. Staff requests that this docket be administratively closed. This administrative closure should not be construed as either an approval or denial by the Commission.
