On March 22, 2017, Global Water- Santa Cruz Water Company, LLC and Global Water- Palo Verde Utilities Company, LLC (collectively, "Global") filed an application with the Arizona Corporation Commission for a waiver under Arizona Administrative Code R14-2-806 related to the merger between Eagletail Water Company, L.C and Water Utility of Eagletail, LLC (collectively, "Eagletail").

On May 25, 2017, Global and Eagletail filed a Motion for Administrative Closure stating the waiver requested in the Application had taken effect pursuant to A.C.C. R14-2-806 (C) and that the merger transaction has closed.

Per Procedural Order filed on June 5, 2017, by Sasha Paternoster, Administrative Law Judge, Global's request for administrative closure of the docket is reasonable and should be approved. Therefore, these dockets are administratively closed.


