12 On February 3, 2017, Table Top Telephone Company, Inc. file an application with the Arizona
13 Corporation Commission pursuant to A.R.S. §40-250 and Arizona Administrative Code R14-2-
103, for a determination of its earnings and the fair value of its investment.

14 On April 13, 2017, Table Top filed a motion to consolidate T-02724A-13-0416 and T-02724A-
15 17-0034, to accommodate Table Top Telephone Company, Inc.'s request to amend Decision No.
16 74830 to remove the requirement for the company to file a full rate case to justify an increase in
17 rates from \$18 to \$20. On May 2nd, 2017, a Procedural Order was issued consolidating T-02724A-
13-0416 and T-02724A-17-0034 and this matter was set for hearing and other procedural
18 deadlines were established.

19 On May 19, 2017, Table Top Telephone Company, Inc. filed a Motion to Withdraw
20 Application.

21 Per Procedural Order filed on May 31, 2017, by Yvette B. Kinsey, Administrative Law Judge,
22 Table Top Telephone Company, Inc.'s request is reasonable and should be approved. Therefore,
23 these dockets are administratively closed.


