Dear Commissioners:

I've enclosed 3 solid reasons to vote "NO" on this presentation.

I. It destroys & dissolves "The Principle Function" of a Corporation Commissioner's purpose, which is to individually determine each entities, "cost of service." This function for five entities will be inherently destroyed by consolidation, setting an unscrupulous precedent. Incentive to conserve and be competitive will be given a deathblow. All to accommodate the company's burden, while minimizing customer relations, since 74% of the customer base oppose it.

II. It's heartbreaking "DISCRIMINATORY<" inasmuch as the three high cost districts will enjoy a gifted reduction, averaging 42% , while the total burden is [placed on the two Sun Cities where Sun City West will face a 20% hike and Sun City will be thrust with a 76% hike. That's the thanks you get for being the two lowest cost districts & most efficient districts.

It is also discriminatory in that it imposes an average hike of of 48% on the two Elderly Retirement Districts while gifting the 3 average higher income districts & younger, with an average reduction of 42% in rates.

There is also a significant difference in home pricing & size between Sun City West & Cortaa Bell according to a real estate study for the months of June/July 2016. Homes in Corta Bella were on average 115% larger in square footage (2,129 sq.ft. vs. 1,849 sq.ft.), sold for 42% higher price(\$164.35 vs. \$115.57 per sq. ft). Another barometer of wealth is the difference in Rec Fees paid. In an 11 community area, Corta Bella ranked 4th. highest @ \$1,678. vs. SCWest @ \$816. vs. Sun City-the lowest @ \$456,

III. Given the extreme rate percentage adjustments, from an average of a 48% hike for two areas & a 42% reduction gift to the other three, in order to achieve singular rate is most akin to a SOCIALISTIC economic philosophy. But that is not surprising given that EPCOR's home base ins Canada, who embraces that concept. But this is the United States that embraces the Capitalistic economic philosophy, where competition & cost efficiency is important. Adoption of consolidation clearly abandons the American System.

For these three reasons, we implore you to vote "NO" and in so doing embellish the image of the Corporation Commission.

I am treasurer of the Lakeforest Condominium Owners' Association in Sun City. When we finished our budget year two and a half years ago, in December 2014 the monthly waste water rate for our 16 homes was \$290.44 representing \$18.15 per unit per month.

As I understand from many articles in the local news and the Sun City Home Owners Association the proposed full consolidation of various EPCOR waste water districts will increase our annual rate to approximately \$41.00 per unit per month. That represents a \$22.85 increase or 126% in less than 3 years! The fixed-income homeowners in our retirement community simply cannot afford such an increase.

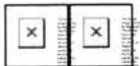
