INTRODUCTION

On May 19, 2017, SNET America, Inc. ("SNET" or "Company") submitted a letter stating it is requesting voluntary decertification and surrendering of operating authority of SNET within the State of Arizona.

BACKGROUND

On July 30, 1997, in Decision No. 60314, the Arizona Corporation Commission ("Commission") granted SNET a Certificate of Convenience and Necessity ("CC&N") to provide competitive InterLATA/IntraLATA resold telecommunications services, except local exchange services, within the State of Arizona.

On April 2, 2014, Citizens Telecommunications Company of the White Mountains, Inc. dba Frontier Communications of the White Mountains, Citizens Utilities Rural Company, Inc. dba Frontier Citizens Utilities Rural, Navajo Communications Company, Inc. dba Frontier Navajo Communications Company and Frontier Communications of the Southwest Inc., on behalf of their parent corporation, Frontier Communications Corporation ("Frontier"), filed an Application at the Commission for a Limited Waiver of the Affiliated Interest Rules in relation to Frontier's proposed acquisition of The Southern New England Telephone Company ("SNETC") and SNET from AT&T Inc. The waiver became effective on the 31st day following the filing of the Application and the docket was subsequently administratively closed in Administrative Closure Number 74584, dated July 22, 2014.

STAFF'S ANALYSIS

SNET states¹ it never had any customers in Arizona. Because SNET has no customers in Arizona, there were no customers to notify and SNET requests² a waiver of the notice of discontinuance of services to customers in Arizona Administrative Code ("A.A.C.") R14-2-1107(A). In addition, because there are no customers, no counties are affected by the discontinuance of service, and SNET also requests³ a waiver of the published notice requirements in affected counties in A.A.C. R14-2-1107(B).

The Consumer Services Section of the Utilities Division reports that there have been no complaints, inquiries, or opinions filed against SNET from January 1, 2014 to May 25, 2017. SNET filed its 2016 Annual Utilities Report on May 16, 2017. SNET is in Good Standing with the Corporations Division. The Compliance Section reports that there are no current compliance delinquencies for SNET.

RECOMMENDATION

SNET America, Inc. is not currently providing resold telecommunications services to any customers in Arizona. Staff recommends that SNET's CC&N to provide competitive InterLATA/IntraLATA resold telecommunications services be cancelled. In addition, Staff recommends approval of SNET's request for a waiver of the requirements to provide direct notice to affected customers and published notice requirements contained in A.A.C. R14-2-1107. Staff further recommends the cancellation of SNET's tariff that is on file with this Commission.

Upon cancellation of its CC&N, SNET will no longer be authorized to provide competitive InterLATA/IntraLATA resold telecommunications services in Arizona and therefore, will no longer be subject to the requirements of Decision No. 60314.
