13	Having considered the entire record herein and being fully advised in the premises, the						
14	Arizona Corporation Commission ("Commission") finds, concludes, and orders that:						
15	FINDINGS OF FACT						
16	1. On March 21, 2013, the Commission issued Decision No. 73783, granting 1-800						
17	Collect, Inc. d/b/a/ Simple Billing Solutions ("1-800 Collect") a Certificate of Convenience and						
18	Necessity ("CC&N") to provide Alternative Operator Services ("AOS") telecommunication services						
19	in the State of Arizona						
20	2. On May 9, 2017, 1-800 Collect filed an application for approval to cancel its CC&N to						
21	provide telecommunications services within the State of Arizona.						
22	3. On June 13, 2017, 1-800 Collect filed its responses to the Commission's first set of data						
23	requests.						
24	4. On June 14, 2017, 1-800 Collect filed a supplement to its response to the Commission'						
25	first set of data requests.						
26	5. On July 3, 2017, the Commission's Utilities Division ("Staff") filed a Staff Report						
27	recommending approval of 1-800 Collect's application.						
28	6. Staff states that the Commission's Consumer Services Section reported there have been

no complaints, inquiries or opinions filed against 1-800 Collect between January 1, 2014, and June 15, 2017. According to the Commission's Corporations Division, 1-800 Collect is in Good Standing. 1-800 Collect filed its 2016 Utilities Annual Report on April 11, 2017, and the Commission's Compliance Section reports that there are no current compliance delinquencies for 1-800 Collect.

- 7. Pursuant to Arizona Administrative Code ("A.A.C.") R14-2-1107(A)(2), telecommunications companies are required to provide notice to all affected customers when they intend to discontinue services. Further, A.A.C. R14-2-1107(B) requires that telecommunications companies publish legal notice of their intent to discontinue service.
- In its application, 1-800 Collect stated it never had any customers in Arizona and requests a waiver of the notice of discontinuance of service to customers.
- Staff recommends the notice and publication requirements contained in A.A.C. R14-2-1107 be waived.
- Staff further recommends approval of 1-800 Collect's application to cancel its CC&N and further recommends cancellation of 1-800 Collect's tariff on file with the Commission.
- Staff's recommendations to waive the notice and publication requirements of A.A.C.
 R14-2-1107 and to approve 1-800 Collect's application are reasonable and should be adopted.

CONCLUSIONS OF LAW

- 1-800 Collect is a public service corporation within the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-281, 40-282 and 40-285.
- 2. The Commission has jurisdiction over 1-800 Collect and the subject matter of the application.
- The cancellation of 1-800 Collect's CC&N to provide AOS telecommunication services in the State of Arizona is in the public interest.
- 4. Granting waiver of the notice and publication requirements set forth in A.A.C. R14-2-1107(A)-(B) is reasonable in this matter.
 - 5. Staff's recommendations are reasonable and should be adopted.

DECISION NO.

1 ORDER 2 IT IS THEREFORE ORDERED that 1-800 Collect, Inc. d/b/a/ Simple Billing Solutions' 3 application to cancel its Certificate of Convenience and Necessity to provide Alternative Operator 4 Services telecommunication services in the State of Arizona is hereby approved. 5 IT IS FURTHER ORDERED that 1-800 Collect, Inc. d/b/a/ Simple Billing Solutions is hereby 6 granted a waiver of the notice and publication requirements set forth in A.A.C.
