## Instructions to Request Cancellation of Letter of Credit

Should you wish to request cancellation of this letter of credit, we require the following steps in order for cancellation of this letter of credit.

1. Return the ORIGINAL letter of credit and any amendments to:

2. Provide instructions to cancel the letter of credit on a separate cover letter. The cover letter must:
  - a. Be on the letterhead of the current beneficiary of the letter of credit.
  - b. Be dated.
  - c. Be signed by an authorized representative of the current beneficiary.
  - d. Indicate the letter of credit number for the letter of credit that is to be cancelled.
  - e. State the following:  
"We are hereby returning your letter of credit number [INSERT LETTER OF CREDIT NUMBER] for cancellation and release Pacific Western Bank of its undertaking for this said letter of credit."

Upon receipt of BOTH of the above mentioned documents, we will effect cancellation of the letter of credit.

PLEASE DO NOT DELIVER THE ORIGINAL LETTER OF CREDIT TO THE APPLICANT FOR CANCELLATION, AS THIS WILL DELAY THE CANCELLATION OF THE LETTER OF CREDIT.
