STAFF'S NOTICE OF FILING **REGARDING PARTICIPATION IN THIS** CASE AND REQUEST FOR A PROCEDURAL CONFERENCE

On January 3, 2018, Stacey Champion filed a formal Complaint against Arizona Public Service Company ("APS") ("Champion Complaint") with the Arizona Corporation Commission ("Commission"). The Champion Complaint was signed by Ms. Champion, and submitted in the form of a Change.org petition including Ms. Champion's name and the names of 425 other individuals represented to be customers of APS. The Complaint relates to the last APS rate case and challenges the reasonableness of certain charges billed customers as a result of that case.

On June 21, 2018, Chairman Forese filed a letter requesting the Utilities Division ("Staff") participation in this case. Chairman Forese asked Staff to respond by June 29, 2018. In response to Chairman Forese's letter, Staff intends to be an active participant in this case.

Because this proceeding has been underway since mid-February 2018, Staff respectfully requests that a procedural conference be scheduled at the earliest possible date to discuss Staff's participation in this case and to consider this proposed procedural schedule to accommodate Staff's involvement.
