**STAFF RESPONSE TO
PROCEDURAL ORDER**

On December 13, 2007, Railroad Safety Section Staff ("Staff") of the Arizona Corporation Commission ("Commission") filed a motion for an indefinite extension on the filing of a Staff Report in the above captioned matter. The basis of the motion was difficulty in ascertaining when Staff would be able to secure a consultant to assist in evaluating the complex issues presented by this application. Procedural order set the filing date for the Staff Report as December 28, 2007. By procedural order dated December 21, 2007, Staff was ordered to file an update indicating when Staff proposes to file a form of Staff Report.

Staff believes that it will be able to file a Staff Report in the above captioned matter no earlier than February 15, 2008 under present circumstances. Staff is in continuing discussion with the potential consultant and believes that discussions will be resolved by January 15, 2008. A further 30 days will be necessary for the consultant or Staff to produce a Staff Report evaluating the present application.


