
20 Timothy M. Hogan, pursuant to Rule 38(a), Ariz. R. Sup. Ct., moves the Arizona Corporation



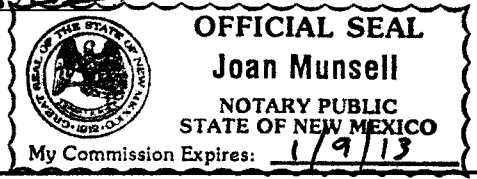
