PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated November 25, 2011, a Procedural Conference was scheduled for December 16, 2011, to discuss the implications on this docket of the FCC's USF/ICC Order adopted on October 27, 2011, and released on November 15, 2011.

On December 9, 2011, AT&T, an active party in these dockets, requested continuation of the Procedural Conference until early February 2012, in order to give the parties more time to analyze the FCC's sweeping and complex order.


No party to the dockets objected to AT&T's request, and the following parties have specifically either joined in the request or indicated no objection: Integra Telecom and PAETEC, XO and tw telecom, ALECA, Sprint, Cox, Centurylink and RUCO.


