BY THE COMMISSION:

On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On September 7, 2012, the Department of Defense and All Other Federal Executive Agencies ("DOD/FEA") filed a Motion to Intervene in this matter. The DOD/FEA mains certain military installations and civilian agency activities in Arizona and purchases a significant quantity of electric service from TEP.

No party objected to the DOD/FEA intervention request.


