NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On September 19, 2012, the Arizona Investment Council ("AIC") filed a Motion to Intervene in this matter. AIC's members include Arizona utility service providers and individuals who hold stock or debt instruments in these utilities. AIC states that its members have a substantial interest in this proceeding as TEP's level of earnings impact debt and equity investors.

No party objected to AIC's intervention.

IT IS THEREFORE ORDERED that AIC's Motion to Intervene is granted.


