NOTIFICATION OF  
INTERVENTION

BY THE COMMISSION:

On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On October 26, 2012, the Southern Arizona Water Users Association ("SAWUA"), an Arizona non-profit corporation, engaged in various activities relating to its members' roles as water providers, filed an Application for Leave to Intervene. SAWUA states that its members' rates could be substantially and directly affected by TEP's rate filing as electric rates represent a significant operating expense for SAWUA's members in connection with their respective operations.

On October 29, 2012, Ms. Cynthia Zwick, an individual concerned about the potential impact of the rate case on low-income and working poor Arizonans filed a Request to Intervene.

No party objected to either intervention.

IT IS THEREFORE ORDERED that SAWUA's and Ms. Zwick's Applications to Intervene are granted.


