RESPONSE TO PROCEDURAL ORDERS


Montezuma Rimrock Water Company, LLC received the October 29, 2012 Procedural Order on November 13, 2012. On November 14, 2012, Montezuma Rimrock Water Company, LLC mailed all filings submitted to date to the Arizona Corporation Commission to John Duggerty as stipulated in Procedural Order dated October 29, 2012. The filings were mailed by certified mail and a copy of the receipt is attached as proof of service.

Montezuma Rimrock Water Company, LLC submitted supporting documents regarding the JD Legal Surcharge on October 9, 2012 which are accessible through edocket with the Arizona Corporation Commission.

Montezuma Rimrock Water Company, LLC hereby requests an extension to Staffs request of Comments/Replies to Staff Report due on January 25, 2013 and the Deadline for new discovery requests on February 6, 2013. Patricia Olsen is a victim in the incident in which Mr. Ivo Buddeke, whereby John Dougherty refers to himself as being Mr. Buddeke's "quasi-legal advisor", was arrested for brandishing his shotgun at Ms. Olsen and her contractors during the installation of the waterline connecting well #4 to well #1. The trial is set for January 24, 2013 and at this time is believed to last for four days. Ms. Olsen must also be made available a few days prior to the trial.

As of this date, Montezuma Rimrock Water Company, LLC has not received any data requests from Mr. Dougherty. However, Montezuma Rimrock Water Company, LLC requests that the response time, should Mr. Dougherty make a request, be extended to three weeks. Mr. Dougherty's data requests in the past have been intentionally onerous and time consuming. Mr. Dougherty has stated to Ms. Olsen, "I'm going to keep harassing you until you drop the criminal charges against Ivo." Ms. Olsen does not have control in regards to the criminal charges Mr. Buddeke faces nor can she change her testimony due to pressure being imposed by Mr. Dougherty. Ms. Olsen believes Mr. Dougherty intends to submit onerous and demanding data requests and that three weeks be allowed in order to respond. Mr. Dougherty is aware that Ms. Olsen is its only employee at this time.
