INTERVENTION

BY THE COMMISSION:

On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On December 11, 2012, Opower, Inc. ("Opower") filed an Application to Intervene. Opower is an energy efficiency software company currently under contract with TEP to deliver its Home Energy Reports solution to 25,000 residential customers to help them use less energy and save money on their electric bills. Opower's program is included in the energy efficiency portfolio that TEP is proposing as part of its rate application and Opower states that the outcome of this docket will directly and substantially impact Opower's business.

No party objected to the intervention.

IT IS THEREFORE ORDERED that Opower's Application to Intervene is granted.


