STAFF'S REQUEST FOR MODIFICATION TO THE PROCEDURAL SCHEDULE

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") due to resource constraints needs additional time in which to file the Staff's Direct Testimony regarding Cost of Capital. According to the procedural scheduled issued by the Administrative Law Judge on September 19, 2012, this testimony is currently due on February 22, 2013. Staff requests an extension of time until March 1, 2013 to file its Direct Testimony, except rate design. This extension applies to Staff and all Intervenors. In addition Staff requests that Arizona Water Company's ("Company") Rebuttal Testimony, which is currently due on April 5, 2013, be due on April 12, 2013 with all other dates remaining unchanged. Staff has conferred with the Company and the Residential Utility Consumer Officer Company ("RUCO") and the Company and RUCO have no objection to the proposed change to the procedural schedule.


