NOTICE OF HEARING

A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and Transmission Line Siting Committee ("Committee") regarding the Application of Arizona Public Service Company ("APS" or "Applicant") for a Certificate of Environmental Compatibility ("CEC") authorizing the construction of the Bagdad 230kV Transmission Line Project ("Project"). The Project consists of a new, approximately 14-mile, single-circuit 230kV transmission line. A map of the Project is attached as **Exhibit A**.

The hearing will be held at Rancho de los Caballeros, 1551 S. Vulture Mine Road, Wickenburg, AZ 85390. **The hearing will begin on Monday, October 28, 2024, at 1:00 pm and will continue as necessary through November 1, 2024, commencing at 9:00 a.m. each day as necessary through the completion of the hearing.** If any

1 revisions to the hearing schedule are required, they will be noticed on the Project
2 website at: aps.com/bagdad and on the Arizona Corporation Commission (“ACC” or
3 “Commission”) website at: www.azcc.gov/arizona-power-plant/meeting-schedule.

7 **MINE ROAD, WICKENBURG, AZ 85390. PUBLIC COMMENT MAY ALSO BE**
8 **TAKEN AT THE BEGINNING OF EACH HEARING DAY OR AT OTHER**
9 **TIMES DURING THE HEARING AT THE DISCRETION OF THE**
10 **COMMITTEE CHAIRMAN.**

11 **PLEASE BE ADVISED THAT ALL LOCAL AND STATE PUBLIC**
12 **HEALTH AND SAFETY GUIDELINES WILL BE FOLLOWED DURING THE**
13 **HEARING AND PUBLIC COMMENT SESSION. RESTRICTIONS ON PUBLIC**
14 **ACCESS, SAFETY PROTOCOLS, AND REVISIONS TO THE HEARING**
15 **SCHEDULE MAY OCCUR DUE TO PUBLIC HEALTH CONSIDERATIONS.**

16 **THE PUBLIC HAS THE OPTION TO WATCH THE HEARING ONLINE**
17 **OR LISTEN TO THE HEARING VIA TELEPHONE.** At least 24 hours in advance
18 of the hearing, information regarding online and telephone hearing access, as well as any
19 additional details regarding safety protocols or other revisions to the hearing schedule
20 will be noticed on the Project website at: aps.com/bagdad.

21 The Chairman may, at his discretion, recess the hearing to a time and place to be
22 announced during the hearing, or to be determined after the recess. The date, time and
23 place at which the hearing will be resumed will be posted on the above-noted Project
24 website and the ACC website.

25 **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE**
26 **GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING**
27 **IS NOT REQUIRED.**

1 No tour is planned at this time. If the Committee decides to conduct a tour, notice
2 that includes a map and itinerary of any such tour will be available at the hearing and
3 posted on the Project website at: aps.com/bagdad and the ACC website
4 at: www.azcc.gov/arizona-power-plant/meeting-schedule. Members of the public may
5 follow the Committee on the tour. During the tour, the Committee may hear testimony at
6 stops on the tour concerning what is visible at the stops and the relevance of the location
7 and view to the Project. No other discussion or deliberation concerning the Application
8 will occur during the tour. A court reporter or recording device will record any
9 testimony taken on the tour for transcription. Public health and safety protocols specific
10 for the tour will be included on the itinerary.

20 Applicant will make available final copies of the pre-filing conference, pre-
21 hearing conference and hearing transcripts at each of the above locations and websites.

22 Each county, municipal government, and state agency interested in the Project
23 that desires to be a party to the proceedings shall, not less than ten (10) days before the
24 date set for the hearing, file a Notice of Intent to Become a Party with the Director of
25 Utilities, Arizona Corporation Commission, 1200 West Washington Street, Phoenix, AZ
26 85007.

1 Any domestic non-profit corporation or association formed in whole or in part to
2 promote conservation or natural beauty, to protect the environment, personal health or
3 other biological values to preserve historical sites, to promote consumer interests, to
4 represent commercial and industrial groups, or to promote the orderly development of
5 the area in which the Project is located that desires to become a party to the proceedings
6 shall, not less than ten (10) days before the date set for the hearing, file a Notice of
7 Intent to Become a Party with the Director of Utilities, Arizona Corporation
8 Commission, 1200 West Washington Street, Phoenix, AZ 85007.

9 The Committee or the Chairman, at any time deemed appropriate, may make
10 other persons parties to the proceedings. Any person may make a limited appearance at a
11 hearing by filing a statement in writing with the Director of Utilities, Arizona
12 Corporation Commission, 1200 West Washington Street, Phoenix, AZ 85007, and the
13 Chairman of the Committee at 2005 North Central Avenue, Phoenix, AZ 85007, not less
14 than five (5) days before the date set for the hearing. A person making a limited
15 appearance will not be a party or have the right to present testimony or cross-examine
16 witnesses.

17 This proceeding is governed by Arizona Revised Statutes (“A.R.S.”) §§ 40-360 to
18 40-360.13 and Arizona Administrative Code Rules (“A.A.C”) R14-3-201 to R14-3-220.
19 No substantive communication, not in the public record, may be made to any member of
20 the Committee. The written decision of the Committee will be submitted to the
21 Commission pursuant to A.R.S. § 40-360.07. Any person intending to be a party to the
22 proceeding on the matter before the Commission must be a party to the proceeding
23 before the Committee.

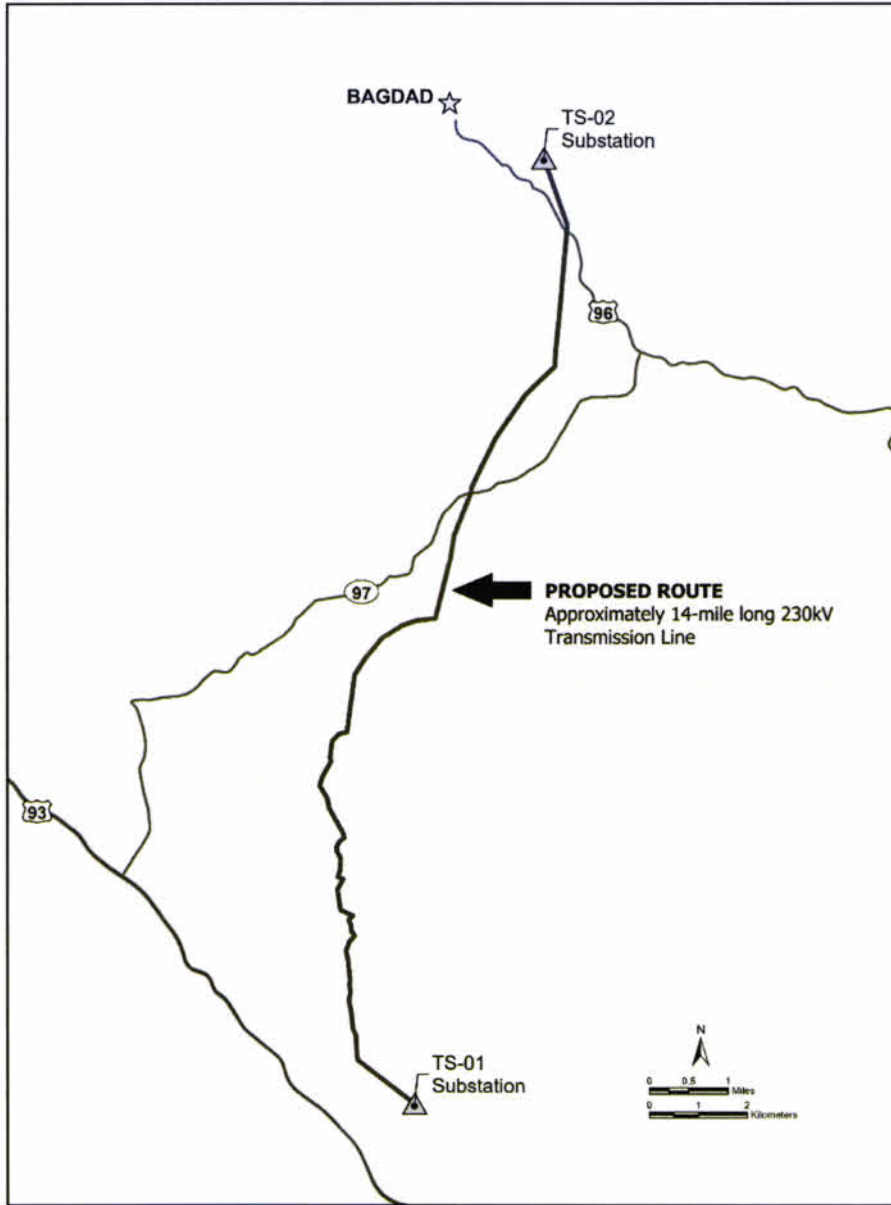
